Cannabis-licensed entities (cultivation, manufacturers, dispensaries and testing facilities) with an established SCCCUCU account over one year. Businesses are required to submit a due diligence package for annual review one month before the anniversary date of the initial account opening. Additionally, businesses are subject to an annual due diligence fee in addition to account fees as quoted. Businesses and individuals are required to submit a due diligence package for initial account review and approval. New accounts are subject to a new account opening fee in addition to account fees as quoted. SCCCUCU account fees will be 0.10% (.001) on all incoming funds with minimum and maximum fees as quoted.	\$1,000	.10% (.001) Incoming funds	\$250	\$2,000

**Account fees are charged the first day of the month on total incoming funds/deposits for the previous month. Transfers of funds between your own accounts are not subject to fees. Incoming funds include wires, merchant processing, deposits, electronic wallet transfers, etc. Per Account means accounts that have a different member account number. Businesses are encouraged to submit annual due diligence packages in a prompt manner. Businesses not meeting annual due diligence package submission deadlines may be subject to additional fees or account closure.
