On November 14, 2025, the funds in this account will be transferred automatically to the member's SCCCU Savings or Checking checking account. ***You must set up an automatic deposit of at least \$100/month to this account from an SCCCU Checking Account. If automatic deposits stop after 60 days, the account will be closed and money transferred to the member's SCCCU Savings Account. ^You can make up to six withdrawals per month from a FlexFund account without penalty. A \$4,999 balance earns a blended rate of 1.77% APY. A \$25,000 balance earns a blended rate of 1.97% APY. A \$30,000 balance earns a blended rate of 1.65% APY.

Dividends are paid from current and available earnings, after required transfers to reserves at the end of the dividend period. Fees or other conditions could reduce earning on any of the accounts listed. Dividend Rate and prospective Annual Percentage Yield are set forth above. The Dividend Rate and APY may change monthly as determined by the Board of Directors. Federally insured by the NCUA.

No additional deposits are permitted to a Certificate once it is opened, unless otherwise disclosed. We may impose penalties for early withdrawal of a Certificate. The penalty can be deducted from either dividends and/or principal. This Certificate is non-negotiable and non-transferable. We will send a reminder notice of the Maturity Date thirty (30) days in advance. If you take no action, the Certificate will renew automatically at Maturity for a like term. The Interest Rate and Annual Percentage Yield on the renewal certificate will be the rate then in effect for like Certificate. A grace period for withdrawal after automatic renewal of seven (7) days will apply. Thereafter, withdrawals of principal balance on the renewed Certificate will again be subject to an early withdrawal penalty until the Maturity Date. Santa Cruz Community Credit Union membership required. Rates subject to change. Federally insured by NCUA.
